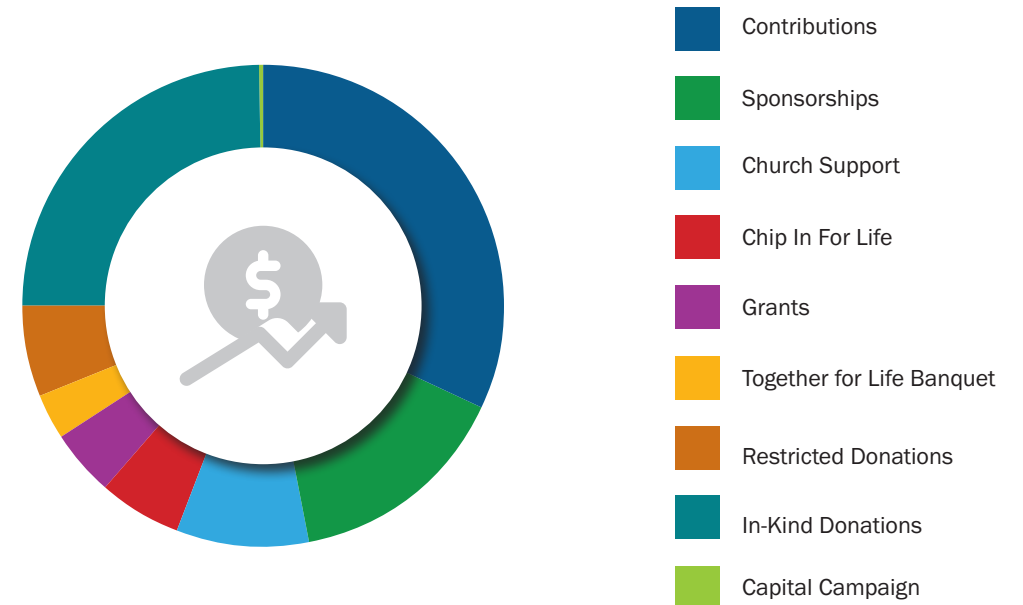
# Financials

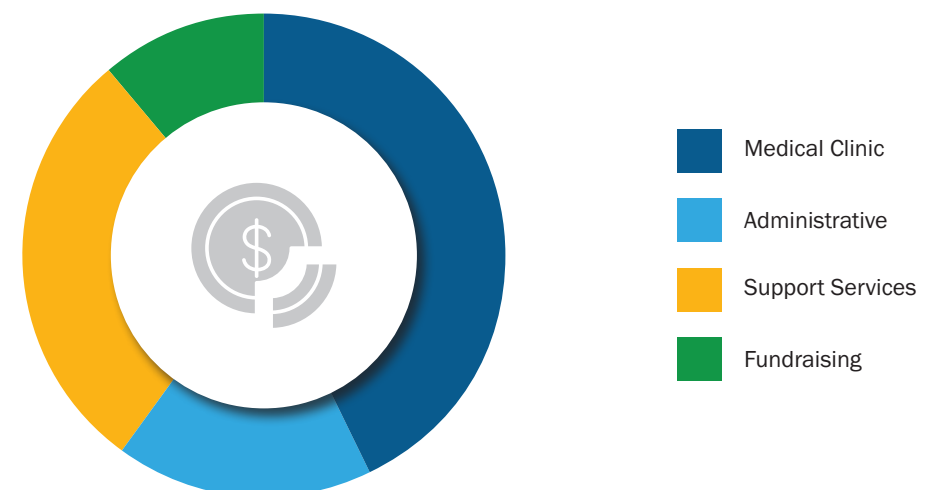
Vida's total revenue for 2022 was \$781,697. Total expenses were \$854,891, without including in-kind donations. In-kind donations and volunteer hours totaled \$256,395. The increased budget for 2022 included the addition of a full-time Support Services Bilingual Supervisor, Support Services Receptionist, and building security enhancements. The increased budget in 2022 also reflected the need to serve more people.

Vida will continue to be a good steward of our limited financial resources, prioritizing patient and client services.
